BAHAWASANYA menurut Fasal (1) Perkara 55 dari Perlembagaan Negara Brunei Darussalam, adalah diperuntukkan bahawa Kebawah Duli Yang Maha Mulia Paduka Seri Baginda Sultan dan Yang Di-Pertuan boleh pada bila-bila masa, dengan Pemasyhuran yang disiarkan dalam *Warta Kerajaan, antara lain,* membubarkan Majlis Mesyuarat Negara.

DAN BAHAWASANYA menurut Fasal (2) Perkara 55 dari Perlembagaan Negara Brunei Darussalam, adalah diperuntukkan bahawa Kebawah Duli Yang Maha Mulia Paduka Seri Baginda Sultan dan Yang Di-Pertuan hendaklah membubarkan Majlis Mesyuarat Negara apabila tamat tempoh 5 tahun dari tarikh ia mula bermesyuarat sesudah ia mula ditubuhkan atau ditubuhkan semula pada bila-bila masa kecuali jika ia telah dibubarkan terlebih dahulu.

DAN BAHAWASANYA Majlis Mesyuarat Negara sekarang ini telah mula bermesyuarat pada 10 haribulan Syaaban Tahun Hijrah Nabi Muhammad Sallallahu Alaihi Wassalam 1425 bersamaan dengan 25 haribulan September 2004.

TO ALL TO WHOM THESE PRESENTS shall come.

GREETINGS:

WHEREAS by Clause (1) of Article 55 of the Constitution of Brunei Darussalam, it is provided that His Majesty the Sultan and Yang Di-Pertuan may at any time, by Proclamation published in the *Gazette*, *inter alia*, dissolve the Legislative Council.

AND WHEREAS by Clause (2) of Article 55 of the Constitution of Brunei Darussalam, it is provided that His Majesty the Sultan and Yang Di-Pertuan shall dissolve the Legislative Council at the expiration of 5 years from the date when it first meets after it is first constituted or is reconstituted at any time unless it has been sooner dissolved.

AND WHEREAS the Legislative Council now in being first met on the 10th day of Syaaban 1425, the Hijriah of Prophet Muhammad (on Whom be the benediction and peace of ALLAH) corresponding to the 25th day of September 2004.

NOW THEREFORE WE in exercise of the powers conferred upon US by the Constitution of Brunei Darussalam do hereby proclaim that the Legislative Council of Brunei Darussalam be dissolved as from the twenty-seventh day of Rejab, the Hijriah of Prophet Muhammad (on Whom be the benediction and

peace of ALLAH) one thousand, four hundred and twenty-six corresponding to the first day of September two thousand and five.

Done at OUR Istana Nurul Iman, Bandar Seri Begawan, Brunei Darussalam this 11th day of Rejab, the Hijriah of Prophet Muhammad (on Whom be the benediction and peace of ALLAH) one thousand, four hundred and twenty-six corresponding to the 16th day of August two thousand and five, being the thirty-eighth year of OUR Reign in Brunei Darussalam.
