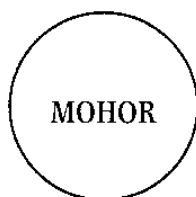

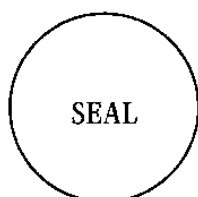

1 April 2006]

An Act to supply a sum out of the Consolidated Fund for the service of the financial year 2006/2007, and to appropriate such sum for certain purposes.

BE IT ENACTED by His Majesty the Sultan and Yang Di-Pertuan with the advice and consent of the Legislative Council as follows:

Citation and commencement.

1. This Act may be cited as the Supply (2006/2007) Act, 2006 and shall commence on the 1st. April, 2006.

Issue and appropriation.

2. (1) The issue of a sum not exceeding \$4,531,014,673.00 (four thousand five hundred thirty one million, fourteen thousand six hundred and seventy three

dollars) out of the Consolidated Fund for the service of the financial year 2006/2007 is hereby authorised.

(2) Such sum is appropriated for the purposes specified in the Schedule.
